<p><b>TERMS AND CONDITIONS</b></p> <ol style="list-style-type: none"> <li>The applicant/company shall submit documents specific to activities that will take place within the jurisdiction of Barangay San Antonio (BSA).           <ol style="list-style-type: none"> <li>Movement of residence</li> <li>Installation of telecommunication services (e.g. internet, telephone)</li> <li>Other activities related to utilities</li> <li>Large-scale delivery of items</li> <li>Setup of mobile and kiosk services (e.g. clinics)</li> <li>TV, film, or commercial shooting</li> <li>Motorcade, fun run, and other street activities</li> <li>All other activities not specified above</li> </ol> </li> <li>This Activity Clearance shall be valid only for the purpose for which it was approved and during the date and time specified. Activities not started therein shall not be allowed, unless renewed and applicable fee is paid.</li> <li>The use of incendiary or explosive devices is strictly prohibited.
